### **Your rights as a client**

Via our data security official in this contact you may at any time exercise your following rights:  
Request information concerning your recorded data and its processing,  
Correction of false personal data or deletion of your recorded data,  
Restriction of data processing in case we cannot delete your data because of legal obligations,  
Objection towards processing of your data by us or towards transmission of your data, in case you have consented to data processing or have sealed a contract with us.

In case you have given us your consent you may at any time withdraw it for the future. You may at any time file a complaint at the responsible authority. Your responsible authority depends on the federal state you live in, work at or where the presumable breach has taken place. ### **Purpose of data processing by the responsible party and third parties**

We solely process your data for the purposes stated in this agreement. We do not forward your personal data to third parties for any but the stated purposes.

### **We only forward your personal data to third parties, in case:**

you have explicitly given us authority to do so,  
the processing is necessary to fulfill a contract with you,  
the processing is necessary to fulfill legal obligations,  
the processing is necessary for the protection of interests and there is no reason to assume that you have a predominant protective interest that your data should not be forwarded.

When being introduced to our services we have explained that your personal data is recorded in our contract of service. In case of liability loss it will be forwarded to the responsible insurance, or respectively, in case we carry liability, towards our tax accountant (necessarily the revenue office). To enable efficient service and contacts, your pre- and surname, your dogs name and your phone contact will be saved on the kennels mobile phone. Your personal data will be deleted when requested, as soon as our cooperation ceases or in the case of objection.

### **Deletion or inhibition of data**

We comply with principles of avoiding data collection and economical data recording. Therefore we

only store your data for as long as necessary for us to fulfill the purposes as specified here or as long as regulated by several legislative terms. After the expiration of certain purposes or deadlines this specific data is routinely deleted or inhibited according to legal regulations.

### **Contact Form**

When you write us any query via email or via the contact form on our website, you give us your unsolicited consent to use your data for purposes of contacting you. The transmission is encrypted by SSL. A valid email address is needed. This is necessary for us to assign the query to you and answer you. The transmission of any further data is optional. Your information will be used only to process your query and possible subsequent issues.

### **Alteration of our data protection agreement**

We reserve the right to alter this agreement, so that it complies with current legal requirements or to adapt it to changes in our services, such as new services offered. In that case the new data protection agreement applies the next time you use our service.
